Smart Document Fulfillment is a distributed data processing, digital print and e-delivery service. It is the first timely, cost-effective, print-on-demand fulfillment process for delivering trade confirmations and related documents to investors.

Relevant information in a single package — Investors are provided with consolidated trade confirmations and, when required, Fund Facts and other required documents. Only information relevant to an investor's trade is digitally assembled, printed, bound together, and mailed as a single package.

Disclosure requirements for investment funds continue to evolve as securities regulators strive to provide investors with timely and relevant information about their investments. Smart Document Fulfillment identifies when investors must receive documents – for example, based on rules around the timing of a transaction, the nature and timing of the last document sent to the investor, and the timing of the last regulatory filing. The system examines each mutual fund trade, and, based on the account fulfillment history, determines if an investor has already received a current document. The system automatically suppresses delivery if the investor has already received the document.

Smart Document fulfillment, integrated with Smart Advisor, addresses the POS Stage 3 requirements to support pre-sale delivery exceptions of Fund Facts in limited circumstances. Smart Advisor is Broadridge's document delivery platform for advisors. It enables pre-sale delivery of Fund Facts.

This combined solution enables tracking of pre-sale delivery of Fund Facts and reconciles them with transaction data for delivery with transaction confirmations.

## Smart Library<sup>®</sup> – Document Repository

Smart Document Fulfillment accesses documents from Broadridge's Smart Library, our proprietary repository for all SEDAR compliance documents and client-specific private library documents. Also, Broadridge has agreements with several mutual fund companies to subsidize all or part of the cost of printing Fund Facts, as part of the Smart Document Fulfillment service. As a result, you can be confident you are cost-effectively delivering current information to your investors.
