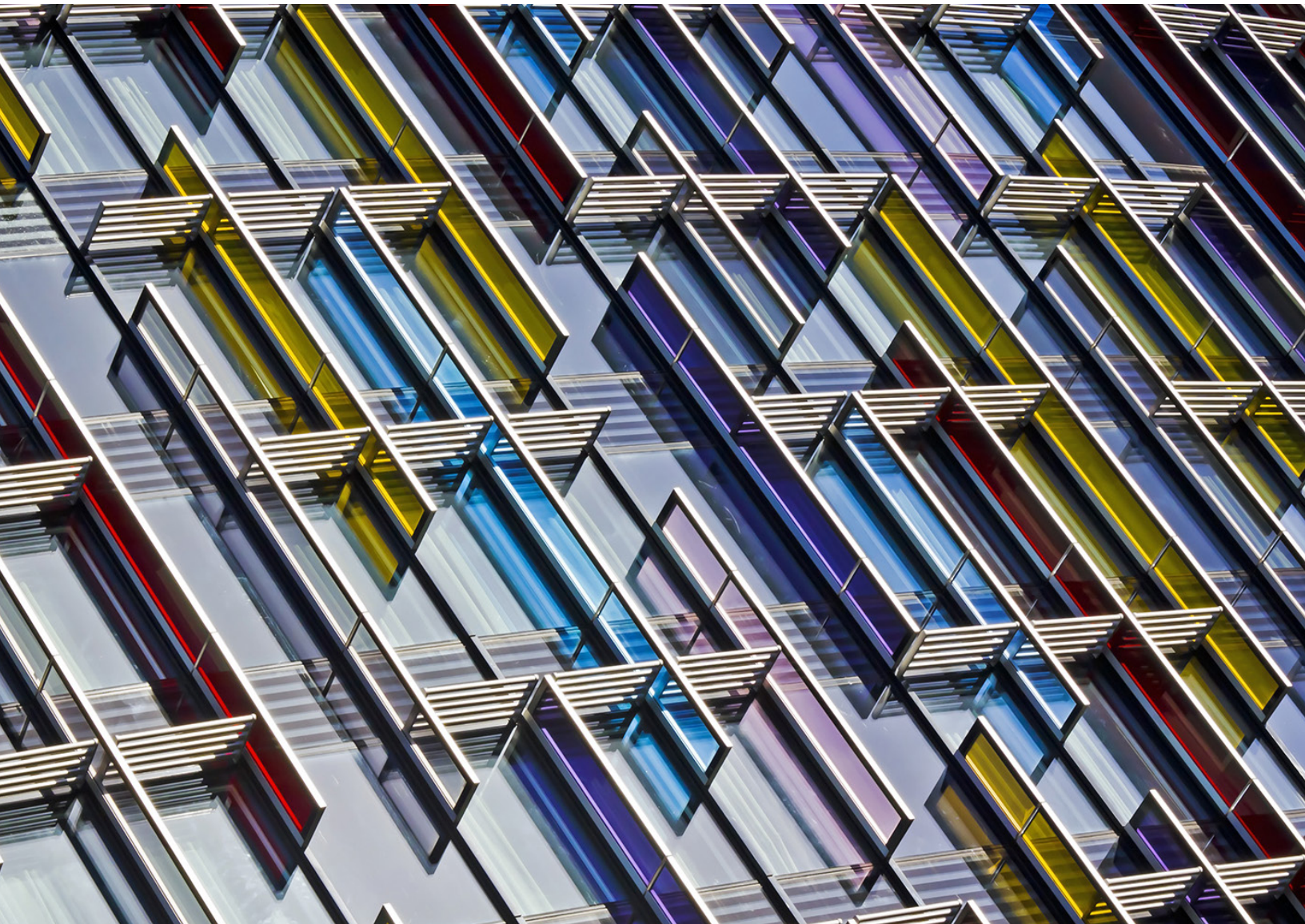

An introduction to Swift Customer Security Controls Framework (CSCF)

Gain visibility into your organization's cyber risk

What is the Swift Customer Security program?

The financial sector is a key target for cyberattacks, and after incidents involving breaches of users' local environments, Swift launched its Customer Security Program (CSP) in 2017 to help institutions implement robust cybersecurity controls through a shared framework of mandatory and advisory measures that evolve to address emerging threats.

Why is Swift CSP so important?

The CSP helps create security standards and a shared framework, which outlines which security measures users should follow to secure their own financial ecosystem and ensure that they maintain high security standards while securely operating their Swift environment.

Swift adapts the framework to existing and new threats and encourages its users to implement, monitor and assess their security controls as part of a broader cyber risk management program.

We propose three different types of risk and control assessment options

Option 1

In-Depth Assessment – Compliant with CSP assessment and self-attestation requirements. Service includes:

- In-depth assessment of all Swift security controls (25 mandatory / 7 advisory) to attest to the full compliance with the Swift CSP Control Framework.
- Review effectiveness of security controls applied to IT systems, applications and processes connected to Swift
- Effort required: **10-15 days****

Option 2

Standard Assessment - Compliant with CSP assessment and self-attestation requirements. Service includes:

- Assessment of mandatory controls only. Focus is on understanding key infrastructure changes, identifying potential gaps and reviewing full CSP compliance with the latest Swift standards.
- Well suited for users with a mature Swift support model and a more established risk and control business function.
- Effort required: **6-10 days****

Option 3

Full risk and control review. Service includes:

- Full risk and control assessment: Initial Swift risk assessment, provide a prioritisation framework and a review of current controls
- Risk Mitigation Planning: Develop a remediation strategy and implementation roadmap to address identified gaps
- Implementation Support: Implement business governance, project management and implementation execution
- Effort required: **Dependent on scope**

**Time and effort will vary based on client architecture type, number of entities or BICs to be assessed

Broadridge CSP process and key activities

CSP Assessment Period (Yearly)

Swift CSP Activities

- **Q1 (January - April)**
 - Swift publishes new CSP framework for next calendar year assessment (typically July of the previous year).
 - Broadridge reviews in detail all updates and changes.
 - Clients should begin reviewing new CSP details to ensure full readiness and understanding of all control changes.
- **Q2 (April - June)**
 - Swift hosts information session for all its users to introduce key changes to CSCF.
 - Broadridge updates in-house CSP training materials and artifacts.
 - Broadridge provides Swift CSP guidance and updates to its clients before the assessment period begins.
- **Q3 (July - September)**
 - Swift attestation window opens in July in Swift KYC-SA.
 - Clients can begin CSP assessment and attestation with their independent assessor.
 - Broadridge initiates CSP engagements and assesses client evidence.
- **Q4 (October - December)**
 - Client and Broadridge discuss and agree assessment results and findings.
 - Broadridge delivers the final CSP assessment report to be submitted to Swift.
 - Clients must provide final sign-off and self-certify in Swift KYC-SA by December 31st
