
# **Investment Philosophy**

# Investment Strategy

The GoalPath 2020 Conservative Portfolio focuses on growth consistent with its target retirement date and, as it approaches its target date, management of retirement income risk. It seeks to allocate between fixed income and equity growth investments to balance income risk management against the opportunity to grow expected retirement income. The overall effect of interest rate fluctuations and equity market performance may impact the ability to achieve a desired level of retirement income. The portfolio may be appropriate for investors with a lower risk tolerance and a planned retirement date on or about 2020. The portfolio invests in an allocation of global equities, global fixed income, and treasury inflation protected securities by investing in mutual funds, collective investment funds, exchange-traded funds and other pooled investment vehicles. The portfolio will initially allocate approximately 32% of assets in global equities. 3% in global fixed income, and 65% in treasury inflation protected securities As the portfolio's target date approaches the global equities and fixed income allocation will be reduced and allocated to treasury inflation protected securities. reaching its most conservative allocation of approximately 25% global equities on or about its target retirement date.


# **Expense Relative to Peer Group**
