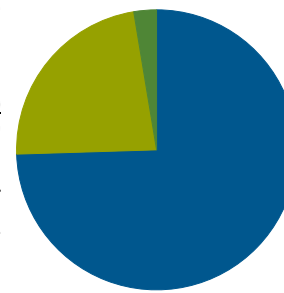

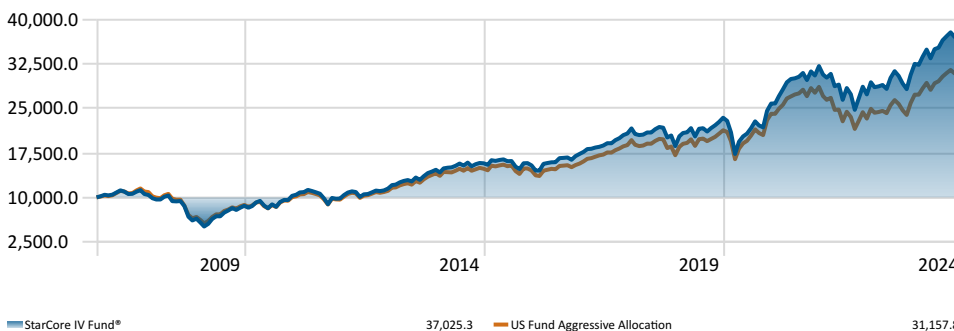
## Asset Allocation
