The StarTrack Retirement Income Fund was originally established as the StarTrack 2010 fund. As the target date approached, risk was reduced on a periodic basis by adjusting the fund's ratio of equity to fixed income mutual funds. Since reaching its target date the Fund has maintained an asset allocation of 30% equity mutual funds and 70% fixed income mutual funds.






