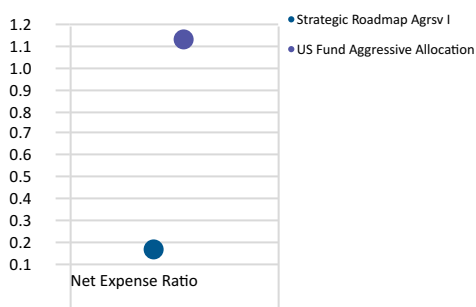

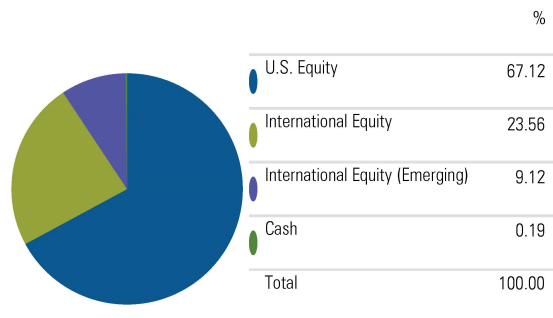
Investment Philosophy

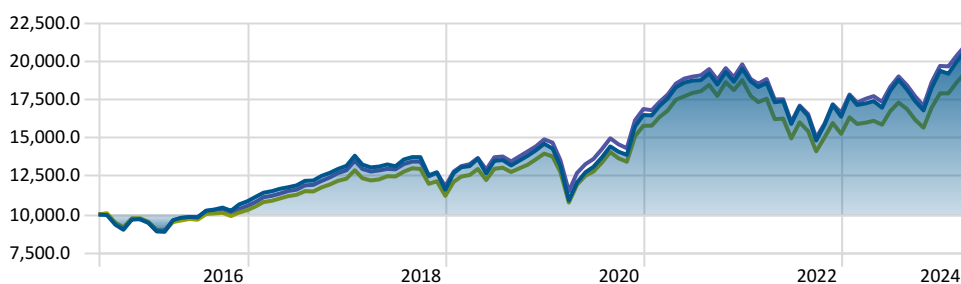
