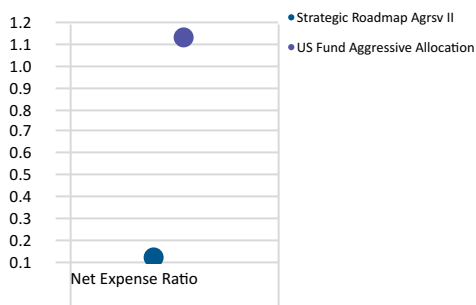

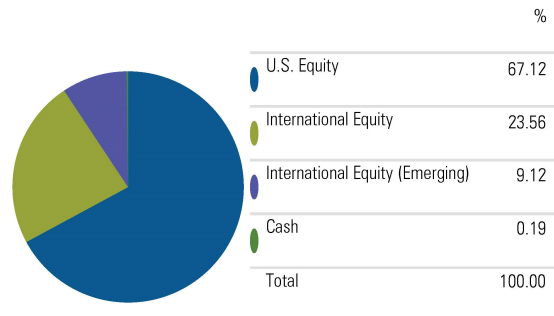
Investment Philosophy

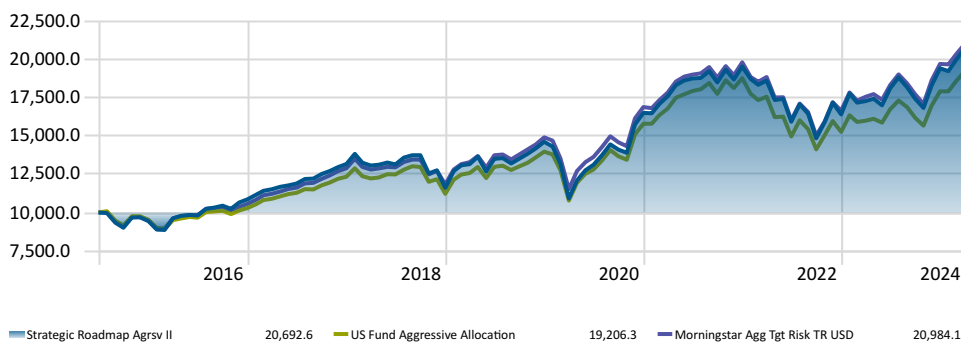
