Investment Strategy

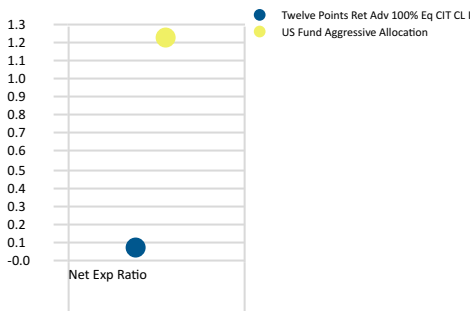
The "Twelve Points Retirement Advisors 100% Equity CIT" is a Fund that seeks current income, capital preservation, and long-term capital appreciation and primarily invests the assets of the Fund among individual equities that provide exposure to U.S. domestic equity market. The Fund typically allocates approximately 100% of its assets to 20 equity securities, though this percentage can vary based on the Sub-Advisor's tactical decisions.

Investment Philosophy

The Sub-Advisor's investment process relies on proprietary quantitative models as well as the Sub-Advisor's fundamental views regarding factors that may not be captured by the quantitative models. In addition, the Fund may invest in cash and cash equivalents or money market funds.

Peer Group (5-95%): Separate Accounts - U.S. - Aggressive Allocation



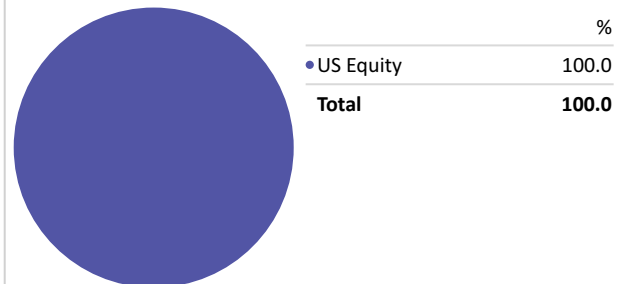

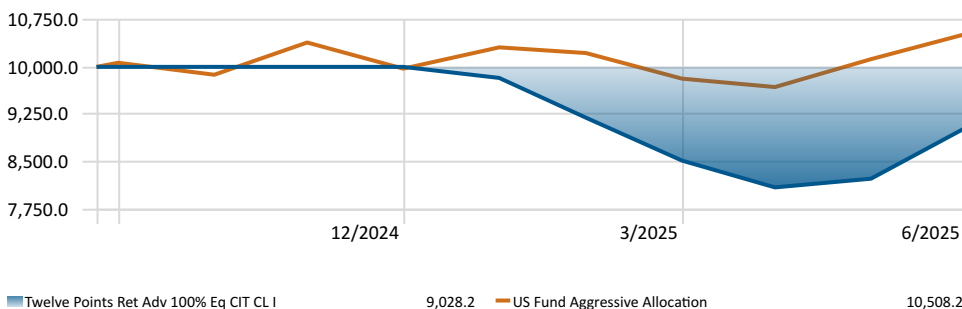
Twelve Points 100% Equity - Asset Allocation
